Murphy, Judge, United States Bankruptcy Court, Northern District of Georgia: (a) that certain Order (Docket No. 216) entered in this case on December 26, 2006, whereby the Bankruptcy Court DENIED Blue Ridge's Motion Requesting Determination of Voting Rights and Allowance of Ballot Cast by Blue Ridge Investors, II, L.P. and Brief in Support Thereof, and (2) Valuation of Collateral, and (b) that certain Order (Docket No. 218) entered in this case on December 29, 2006, whereby the Bankruptcy Court DENIED the Motion to Approve Emergency Bidding Procedures filed by the Official Committee of Unsecured Creditors, and (c) that certain Order (Docket No. 219) entered in this case on December 29, 2006, whereby the Bankruptcy Court DENIED the Emergency Motion for Continuance of Confirmation Hearing filed by the Official Committee of Unsecured Creditors.
